

# Accelerator #35

#### Additive, Activator

## **Typical Processing**

1. Add .25-5% by volume into your compatible acid bath for improved surface cleaning. Note: Use lowest temperatures practical when using Accelerator #35. Heat causes a faster use rate.



2. Temperature: Room temperature usually.

Note: Added gaging and frothing will occur with the use of this product, it is important to determine proper use level.

3. Time: Product works rapidly. Dilute entire system to meet your process time schedule if necessary. 1/2-5 minutes.
